- The seller declares that, to the best of her knowledge and following veterinary examination, the above-mentioned kitten is at the time of sale in good health and free from diseases, defects, parasites, and/or skin conditions.
- If the buyer wishes to have the kitten retested, this must be done on the first working day after transfer, including any health checks. Such examinations must be carried out by a licensed veterinarian. Should such an examination reveal that the kitten was not in good health at the time of sale, this must be certified in writing by the veterinarian on official letterhead, stating the diagnosis and findings, and signed by hand (a stamp alone will not be accepted). If, after transfer, the kitten has been in contact with other cats or dogs, the breeder cannot be held liable for any illness discovered during examination (except for hereditary issues). If the kitten has not been in contact with other cats or dogs, the buyer is entitled to return the kitten within 24 hours of such examination.
- The breeder's liability for any defects is limited to taking back the kitten. Veterinary expenses will not be reimbursed by the breeder.
- The seller declares that the kitten has been given all necessary care and attention to grow into a healthy and social cat.
- The kitten has been microchipped and received two vaccinations. The seller confirms that the vaccination booklet has been handed over to the buyer.
- The seller declares that the pedigree and ownership certificate have been received or will be sent once the kitten has been neutered/spayed. This must be done before the age of six months.
- The kitten is sold as a pet only. The buyer agrees to a breeding prohibition. If offspring are

- produced from this cat, the buyer owes the seller a penalty of €500 per kitten (applicable only if the kitten has not yet been neutered/spayed).
- The seller will compensate the buyer by offering a replacement kitten of comparable quality free of charge if the purchased kitten dies before the age of two years due to hereditary or congenital defects. This does not apply in cases of infectious diseases, viruses, or parasites. In case of death within two years, a written and signed statement from a licensed veterinarian, on official letterhead, specifying the cause, is required.
- Veterinary expenses will under no circumstances be reimbursed.
- In case of discovery of a hereditary defect, the buyer is obliged to inform the seller. The seller has the right to request a second opinion at the seller's expense. The buyer also declares to notify the seller as soon as possible in case of the kitten's premature death.
- The buyer declares to feed the kitten the same diet as provided by the breeder for at least the first month after transfer. If the buyer wishes to change the diet, it is advised to gradually mix the new food with the old over a period of four weeks, as Bengals have sensitive digestive systems. Stress from relocation combined with a sudden change in diet may cause diarrhea. The buyer confirms having been informed about the kitten's diet and portions.
- The buyer declares to provide the kitten with a loving home.
- The buyer declares not to confine the kitten to cages.
- The buyer declares never to place the kitten in a shelter.
- The buyer declares not to be a trader and that the kitten will grow up in their home.
- The new owner assumes full responsibility for the kitten from the moment of purchase. All legal expenses resulting from any breach of this contract will be borne by the buyer.
